As of today, our clinical operations are proceeding as normal, aside from the following exceptions.

We are continuing to cancel all elective procedures and have instituted a no-visitor policy with specific exceptions. In all of our hospitals, all caregivers will need to answer a few questions and have their temperature taken at the designated entrances for each campus. We know that this is an inconvenience for all of our Catholic Health associates, but we must take these steps to protect our patients, our colleagues, and our community.

After evaluating a number of patients for COVID-19 over the past several weeks, today we learned that we now have **our first positive result in a patient who was evaluated earlier in the week in one of our facilities, the Mount St Mary Campus**. We treated the patient consistent with CDC and local guidelines, with all the required precautions in collaboration with the Health Department. Throughout our county, several cases have now been reported. To date, most are travel-related, but we now have signs of sustained community transmission in Western New York State.
